1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 12,712.48 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

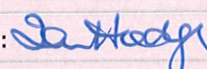

Auditor General for Wales' Audit Certificate and report

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2022 of:

Auditor General's report

Audit opinion – Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

Members' interests

I note that during meetings, members declare their interest in relevant matters to be discussed and decided by the Council. However, it is not clear from the minutes whether or not those members who declare interests leave the meeting and do not participate in discussions. We recommend that the Council ensures that following the declaration of an interest, individual members leave the meeting and that this is recorded in the minutes.

Employees salaries

Due to changes in employees pay (inflation and incremental pay awards), there was not a clear audit trail from employee contracts to current pay. We recommend that the Council ensures that agreed changes to pay documented as attachments to contracts as changes are made.

Compliance with standing orders

The Council's standing orders for contracts require the Council to obtain quotes for purchases above set thresholds. This does not prevent the Council awarding a contract if it has been unable to obtain the required number of quotes. Our audit identified that where the Council is unable to obtain the required number of quotes, it does not have an adequate record of this circumstance when it awards the contracts. We recommend that where the Council has not been able to obtain the required number of quotes, that this is recorded in the minutes at the time the contract is awarded.

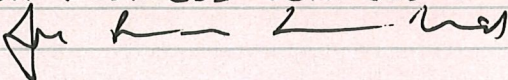
